	could not inspect the roof as it is three stories high. The roofer informed them that	
	the chimneys were unsafe. They believed they were doing the safest thing by	
	removing them, they didn't realise that they would need planning permission for

	this as the building was not listed and was not in a conservation area. They have been quoted to replace the chimneys it will cost them £72,000.00.	
	Jane Llewellyn read out a comment from Peter Wheelhouse, EDRM supporting the application and a letter of objection from Martin Bax and advised the Panel of Mendips Conservation Officers comments.	
	Richard Ackroyd asked James and Amanda Hatt if removing the chimneys had given them extra room. They stated that the chimneys were built into the wall so no extra room was gained from removing them.	
	James and Amanda said that they have spoken with Peter Wheelhouse and are seriously thinking about using the top floor for employment use. They also mentioned that they are local independent business owners who have recently taken on two new employees.
