Mendip District Council are consulting on a pre-submission draft of the Local Plan Part II between **Tuesday 2nd January and Monday 12th February 2018**. This is the formal stage of consultation before the Plan is submitted for examination by the Secretary of State.

This Plan allocates additional sites for housing, employment and community facilities across Mendip. There are additional policies identifying Local Green Spaces and existing Employment Sites. The plan contains a draft policy to promote Self and Custom build housing. A separate Supplementary Planning Document has been prepared to provide additional information.
