	Jane Llewellyn stated that she had received a request from a member of public for the							
	Town Council to look at the propose incinerator application in Westbury.							
	Nadia Evans raised her concerns with this application which included incinerating not							
	being renewable energy, creation of dioxins, the incinerator producing up to 40%							
	residue that consists of bottom ash and fly ash and lorries that will have to dispose of toxic waste which will increase Co2.							
	Jane summarised an email received from Mendip District Cllr Michael Dunk which raised the following concerns. These included the prevailing South West wind blowing towards							
	Frome, the proximity to the built-up area, the amount of HGV vehicle movements using							
	the local roads 24 hours a day, which will add to the air and noise pollution, the lack of							
	information regarding the technology to mitigate and monitor the flue gases, harmful							
	chemicals and that Frome Town Council, Mendip District Council and Wiltshire Council							
	have declared a climate and ecological emergency, burning of waste will create more							
	greenhouse gases and we have tight targets to reduce them, emissions and dioxins.							
	Cllr Horton said he totally agrees with opposing to this application because of all the							
	reasons already stated. Incinerators have come about because we produce far too much							
	waste and if we then deal with the waste by burning it, we then have to continue							
	producing too much waste in order to feed the incinerator. When actually we need to be							
	producing too made made in order to reca the memoriator. Which detading We field to be	1

reducing our waste so creating more incinerators, when there are already some close by for example Avonmouth, we have to continue producing more and more waste which is counterproductive.

Jane mentioned that FTC have objected to all of the previous application on the basis of the increase of traffic and pollution over the town.

Cllr Gore asked if anyone knew more about the Avonmouth site. Cllr Gore mentioned she seen in a Somerset Waste newsletter that the plant was modern and had a high burning rate so that there were very low pollutants, but maybe that will not get rid of the amount of ash. If we have one in Avonmouth do we need one in Westbury? If Avonmouth is a high end, modern version why are we getting another alternative so close. I would like to disagree with the one at Westbury but I would like to know more about this form of waste disposal, as waste is a big problem.

Cllr Ackroyd mentioned that there is a big incinerator on the way to Gloucester, is this the same sort of size and same kind of incinerator? Nadia Evans said it is exactly the same technology.

Cllr Gore asked if there is a website that has information on the Westbury incinerator? Jane mentioned there are several campaign groups on Facebook. Lenka Grimes confirmed that there is a Facebook group called WAAG.

Cllr Horton mentioned that having an incinerator doesn't give anyone an incentive to change, and an excuse for manufactures to carry on as they are.

Cllr Hills added that it is a disincentive in the plastic industry to recycle, so if it is burnt and then therefore cannot be recycled they will need to keep producing virgin plastic. Jane stated that anyone can make representations on planning applications.

Cllr Horton asked if making the objections Frome-based has any weight? As we don't want the pollution over Frome but we don't want them over Westbury either. Jane replied the issues were listed as a whole then as Frome specifically. It won't strengthen the objection but it will say to residents of Frome and Westbury that we are objecting on behalf of the residents in Frome but also thinking about Westbury residents at the same time.

Cllr Hills asked to add to question the need for it given the Swindon and Avonmouth incinerators proximity.

Cllr Tanner said it doesn't sit with our declared climate emergency.

The response for this application Objection

The proposal will increase vehicle movement through Frome and this will mean an increase in the associated pollution from those vehicles, which will have an impact on the residents of Frome and the Environment. The proposal will also mean an increase in greenhouse gases and toxins from the incinerator, which will drift towards Frome, again having an impact on the residents of Frome and the environment.

Frome Town Council, Mendip District Council and Somerset County Council have all declared a Climate and Environmental emergency, we should be encouraging people to produce less waste rather than providing additional incinerators. There are already two incinerators within close proximity, at Swindon & Bristol.
