

**Somerset County Council**  
**Mendip District**

Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended, have made an Order prohibiting all traffic from proceeding along:

Temporary Road Closures:

SD007413 - MD01 – Rodden Farm Lane in the parish of Selwood. Rodden Farm Lane from the junction with A3098 Styles Hill to 640 metres from the junction with the A3098 Styles Hill, for a distance of 640 metres.

SD007414 - MD02 – Millards Hill House to Witham Hall Farm in the parish of Trudoxhill. Millards Hill House to Witham Hall Farm from the junction with Witham Hall Farm to Bunns Lane and Bindon Lane to Witham Hall Farm to the junction with Millards Hill and Foghamshire Lane to Gare Hill, for a distance of 1020 metres.

SD007415 - MD03 - Southfield Hill and Chickwell Lane in the parish of Hemington. Southfield Hill and Chickwell Lane from the junction with A362 Buckland Belt to the junction with A366 Wells Road, for a distance of 5250 metres.

SD007416 - MD04 - Tynning Hill to Faulkland in the parish of Hemington. Tynning Hill to Faulkland from the junction with Park Lane and Tynning Hill to the junction with A366 Park Lane to Grove Lane, for a distance of 655 metres.

SD007417 - MD05 - B3139 White Post to Charlton Road, Charlton Road to Kilmersdon Hill, Kilmersdon Hill, Kilmersdon Hill to Frome Road in the parishes of Stratton on the Fosse, Kilmersdon and Hemington. B3139 White Post to Charlton Road, Charlton Road to Kilmersdon Hill, Kilmersdon Hill, Kilmersdon Hill to Frome Road from the junction with A367 White Post roundabout to the junction with A362 Frome Road, for a total distance of 6318 metres.

SD007418 - MD06 - Holt Lane, Bindon Lane to Witham Hall Farm & Witham Hall Farm to Bunns Lane in the parish of Witham Friary. Holt Lane from the entrance to Sweetnap Farm to the junction with Foghamshire Lane to Gare Hill, for a distance of 6720 metres.

SD007419 - MD07 - Brottens Road & Chesterblade Road in the parish of Doulling. Chesterblade Road from the junction with Winterwell Lane to Brottens Road from the junction with Maesdown Road and Farm Road, for a distance of 2930 metres.

SD007420 - MD08 - Smiths Lane to Folly Cottages, Millford Lane to Smiths Lane & West Lane to Milford Lane in the parish of Ditcheat. Smiths Lane to Folly Cottages, Millford Lane to Smiths Lane & West Lane to Milford Lane from the junction with

West Lane to the junction with Wraxhall Road to Folly Cottages, for a distance of 1420 metres.

SD007421 - MD09 – West Lane in the parish of Ditcheat. West Lane from the junction with West Lane to Milford Lane to the 820 metres westwards from the junction with West Lane to Milford Lane, for a distance of 820 metres.

SD007422 - MD10 – Moor Lane and Bolters Lane in the parish of Ditcheat. Moor Lane from the junction with West Lane to Bolters Lane, 10 metres north-eastwards from the junction with Moor Lane, for a distance of 1230 metres.

SD007423 - MD11 - B3139 Wells Road and Barrow Causeway in the parishes of Wookey and Bleadney. B3139 Wells Road and Barrow Causeway from 420 metres west from the junction with Tilleys Drove to 80 metres south-westwards from the junction with Castle Lane, for a distance of 3820 metres.

SD007424 - MD12 – New Road in the parish of Draycott. New Road from the junction with A371 Wells Road to the junction with B3135 Roemead Road, a distance of 3630 metres.

SD007425 - MD13 - Westfield Lane and Wootton Street in the parish of Butleigh. Westfield Lane from the junction with Reynalds Way to Wootton Street from the junction with Butleigh Road & Sub Road, for a distance of 2130 metres.

SD007426 - MD14 – Bolster Lane in the parish of Butleigh. Bolster Lane from the junction with Reynalds Way to the junction with Wood Lane, for a distance of 1090 metres.

SD007427 - MD15 – Compton Street in the parish of Butleigh. Compton Street from the junction with Wood Lane to the junction with Sub Road, for a distance of 840 metres.

SD007428 - MD16 – Wood Lane in the parish of Butleigh. Wood Lane from the junction with Sub Road to the junction with Westfield Lane and Wootton Street, for a distance of 2720 metres.

SD007429 - MD17 - Henley Lane in the parish of Butleigh. Henley Lane from the junction with Barton Road to 660 metre northwards from the junction with Barton Road, for a distance of 660 metres.

SD007430 - MD18 - Chilcote Lane, Chilcote Drove & Lyatt Lane in the parish of St Cuthbert Out. Chilcote Lane from the junction with Old Frome Road to Chilcote Lane from the junction with Sleight Lane & Crapnell Lane; including Lyatt Lane from the junction with Chilcote Lane for a distance of 640 metres; including Chilcote Drove, from the junction with Chilcote Lane to the junction with Old Frome Road, for a total distance of 3400 metres.

SD007431 - MD19 - Upper Wellesley Lane & Wellesley Lane in the parish of St Cuthbert Out. Upper Wellesley Lane from the junction with Launcherley Lane to Upper Wellesley Lane from the junction with Dulcote Hill Lane; including Wellesley Lane from the junction with Upper Wellesley Lane to the junction with Lower Wellesley Road, for a total distance of 2795 metres.

SD007432 - MD20 - Binegar Bottom in the parish of St Cuthbert Out. Binegar Bottom from the junction with B3135 Roemead Road to the junction with Nevilles Batch and Highcroft Lane, for a distance of 1690 metres.

SD007433 - MD21 - Tellis Lane, Kings Lane, Turners Court Lane & Emborough Pond Lane in the parish of Emborough. Tellis Lane from the junction with A37 Underhill to Marchants Hill to the junction with B3139 Bath Road, for a total distance of 1620 metres.

SD007434 - MD22 – Tor Hole Road in the parish of Chewton Mendip. Tor Hold Road from the junction with B3135 Roemead Road to the junction with A39 Bathway, for a distance of 3320 metres.

This Order will enable Somerset Highways to carry out phased preparation works and surface dressing works.

The Order becomes effective on 30<sup>th</sup> December 2021 and will remain in force for eighteen months. The phased works are expected to commence any time after 4<sup>th</sup> January 2022.
