**(REVOCATION AND PROHIBITION OF VEHICLES)**  
**ORDER 2021**

SOMERSET COUNTY COUNCIL in exercise of its powers under Sections 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

This Order shall come into force on the 28<sup>th</sup> day of October 2021 and may be cited as "Somerset County Council (Various Roads, Frome) (Parish of Frome) (The Frome Independent Sunday Market) (Revocation and Prohibition of Vehicles) Order 2021".

1. Except as provided in Article 3 of this Order, no person shall cause any motor vehicle to enter, proceed or wait in on the lengths of road, as specified in Schedule 1 to this Order.
2. The Somerset County Council (Frome Sunday Market) (Prohibition of Motor Vehicles and Revocation) Order 2017 is hereby revoked.
3. Nothing in Article 1 of this Order shall apply so as to
  - (a) for the conveyance of goods and merchandise to or from any premises situated on or adjacent to that length of road, provided that any vehicle cannot be used for such purpose before 0600 hours or after 1800 hours on the day the prohibition is in effect;
  - b) prevent any person from causing any motor vehicle to proceed in the length of road referred to that Article if the vehicle is being used in connection with any building operation or demolition in or adjacent to that road, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred, or the laying, erection, alteration or repair in or near to any of the said lengths of road of any sewer, or of any main pipe or apparatus for the supply of gas, water or electricity or of any apparatus as defined in Paragraph 1 (1) of the Telecommunication Code contained in Schedule 2 to the Telecommunications Act, 1984.
  - c) the vehicle, if it cannot conveniently be used for such purpose in any other road to be used in the service of a local authority, the Environment Agency,

- a water undertaker or sewerage undertaker in pursuance of certain statutory powers or duties.
- d) prevent emergency vehicles in pursuance of their duties from proceeding in the lengths of road specified in the schedules to this Order.
- e) in connection with the setting up and removal of market stalls,
- f) licensed taxis and scheduled buses,
- g) residents whose usual residence is located on roads contained in the schedule to this Order.
- h) vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

## **SCHEDULE 1**

### **Prohibition of Vehicles**

**between the hours of 06:00 to 18:00 on the first Sunday of each month only**

Catherine Hill, Frome	Between the junctions with Stony Street and Whittox Lane
Stony Street, Frome	For its entire length
Market Place, Frome	For its entire length
The Bridge, Frome	Between the junctions with Scott Road and Willow Vale
King Street, Frome	For its entire length
Scott Road, Frome	For its entire length
B3090 North Parade, Frome	Between its junction with Willow Vale to its junction with Welshmill Road
Justice Lane, Frome	For its entire length
Bridge Street, Frome	For its entire length
Palmer Street, Frome	For its entire length
B3090 Bath Street, Frome	From its junction with Palmer Street to its junction with Market Place
Cork Street, Frome	From its junction with Christchurch Street to Berkley Road (Market Place) for a distance of 140 metres in a north westerly direction

## **SCHEDULE 2**

### **Revocation**

The Somerset County Council (Frome Sunday Market) (Prohibition of Motor Vehicles and Revocation) Order 2017 will be revoked.
