MD-04/22 - RS005887 - Bagborough Lane in the parish of Pylle; from the junction with A37 Fosse Way to the junction with the A371 Redlands Farm Lane to Prestleight Road, a total distance of 2,070 metres.

MD-04/22 - RS005888 - Ball Lane to Piers Road in the parish of Cranmore; from the junction with A361 Cranmore Road to 360 metres from the junction with A361 Cranmore Road, a total distance of 360 metres.

MD-04/22 - RS005889 - Buckland Lane & Elm Lane in the parishes of Great Elm and Buckland Dinham; from Buckland Lane, the junction with Elm Lane to Hapsford Hill to Elm Lane, the junction with Sands Cross Lane and Lower Street, for a total distance of 1,640 metres.

MD-04/22 - RS005890 - B3151 Glastonbury Road in the parish of Meare; from 190 metres north-westwards from the junction with Back River Drove to 1,690 metres north-westwards from the junction with Back River Drove, for a total distance of 1,500 metres.

MD-04/22 - RS005891 - Homefield Close and Rylands in the parish of Beckington; from Homefield Close, the junction with Sandy Lane to Rylands, 155 metres from the junction with Homefield Close, for a total distance of 185 metres.

MD-04/22 - RS005892 - Somerville Road in the parish of Wells; from the junction with Kennion Road to 75 metres from the junction with Kennion Road, for a total distance of 75 metres.

MD-04/22 - RS005893 - Sun Batch in the parish of Draycott; from the junction with Swans Lane to 465 metres from the junction with Swans Lane, for a total distance of 465 metres.

MD-04/22 - RS005894 - Chapel Lane to Stockhill, Chapel Lane and Zion to Underhill in the parishes of Binegar and Gurney Slade; from Chapel Lane, junction with the A37 Old Frome Road to Underhill to Chapel Lane to Stockhill, 390 metres from the junction with Zion to Underhill; including Zion to Underhill, 35 metres northwestwards from the junction with Chapel Lane to 15 metres south-eastwards from the junction with Chapel Lane, for a total distance of 480 metres.

This Order will enable Somerset Highways to carry out phased preparation works and resurfacing works.

The Order becomes effective on 24th March 2022 and will remain in force for eighteen months. The phased works are expected to commence any time after 1st April 2022.
