2025/36/FC	<p>The meeting started at 7pm</p> <p>The Chair of Council, Cllr Andy Jones sent his apologies. In his absence Fiona Barrows proposed Steve Tanner as Chair of the meeting, seconded by Mark Dorrington, agreed unanimously. Steve took the chair.</p> <p>Max Wide arrived at 7.02pm</p> <p>1. Election of Chair and Deputy Chair</p> <p>Nick Dove proposed Fiona Barrows as Chair 2025/26, seconded by Polly Lamb, agreed by majority. Fiona Barrows abstained.</p> <p>Fiona Barrows expressed her emotional response to being proposed as the new Chair, sharing her struggles with mental health and late diagnosis of ADHD. Fiona highlighted the importance of inclusivity in local democracy, emphasising that her election created conditions for others to take on similar roles. She noted the challenges faced by local communities, including the housing crisis, marginalisation of young people, and struggles of local businesses. Fiona called for a bold and innovative approach to make Frome a more resilient and fairer place, thanking the council for voting her in.</p>

2025/37/FC	<p>2a. Apologies for absence Max Wide proposed to accept apologies from Carla Collenette, Andy Jones, Ben Still and Mel Usher, seconded by Philip Campagna, agreed unanimously.</p> <p>2b. Minutes from the last meeting on 30 April 2025 The minutes of the Frome Town Council meeting held on 30 April 2025 were approved as a true record of the meeting and signed by the Chair.</p> <p>Proposed by Polly Lamb, seconded by Anita Collier, agreed unanimously.</p>	
2025/38/FC	<p>3. Questions from public and Cllrs Lenka Grimes raised concerns about a motion regarding housing and asylum seekers at Somerset Council, which she felt was divisive and misleading. She highlighted the issue of Airbnb properties contributing to the housing crisis and called for action to address it. Steve Tanner offered to meet with Lenka to discuss the data around second homes and Airbnb's in Frome.</p> <p>Nick Dove was concerned about Somerset Council's poor response to issues reported through Fix My Street and also provided examples of unanswered emails and requests for meetings, highlighting the need for better communication and service delivery. Fiona Barrows suggested trying to address the issue with Somerset Council formally and exploring a system for raising issues.</p> <p>Nick also asked whether there was a system in place for staff to record how much time they spent different projects. Paul Wynne replied that there wasn't.</p> <p>Tracey Ashford arrived at 7.21pm.</p>	ST

For decision - To decide on Cllrs and the Chair’s allowance</p> <p>Paul Wynne presented the rent.</p> <p>Cllrs noted the report and in particular the recommendations of the Somerset Parish Remuneration Panel as well as the legal advice sought from Bevan Brittan.</p> <p>Anne Hills and Nick Dove supported the proposal, emphasising the importance of making the role accessible to a wider pool of people.</p> <p>Max Wide clarified that the allowance was intended to enable Fiona to take on the role, not to establish an allowance in perpetuity.</p> <p>There was a discussion about the amount of the chair’s allowance and Steve Tanner proposed to set the Chair’s allowance at £15k for 2025/26, seconded by Anita Collier, agreed by majority. Lisa Merryweather, Philip Campagna and Fiona Barrows abstained.</p>
