****Highways lighting:** A resident and I are working with other Somerset Councillors and National Highways to ensure the lighting along the surrounding roads is operational.

****Leisure Centre:** Residents have raised concerns about the squash courts and have also praised some of the improvements. I have been in touch with Somerset Council Officers who look after the lease of the Leisure Centre. There are plans for a new business plan for the facilities and this should be in place by April. I will update as I get more information. And I will update the residents accordingly.

****Bins:** Residents have asked for a new bin on Christchurch Street West (at the bus stop) and asked for another bin to be properly marked. The bin team is looking into these requests. I will update the residents directly. I have also raised concerns about the bin service since Somerset Council has taken this in-house. I will advise accordingly.

****Buses:** I hope to meet with the Somerset Bus Partnership in the next few weeks to discuss what they will be requesting from the government grant given to Somerset for bus improvement (and which I raised publicly at full council in 2025).

****Planning, licensing & illegal activity:** Any legal concerns are to be raised directly with the police. Licensing issues need to be raised with the licensing team at the council directly through the website with the support of local Somerset Councillors. Planning is handled directly with the council's East planning team, which will also include the Enforcement Officer. There are currently over 400 enforcement cases backlogged with only one (possibly temporary) Enforcement Officer.

****Reporting Highways issues:** To help ensure timely action on any future concerns, Somerset Council is encouraging parish councils and members of the public to report urgent highway defects through the online reporting tools, where they can be logged and assessed promptly.

****Government Rates Somerset's Road Conditions Among the Best in the Country:** Somerset Council has been ranked among the top performing authorities in England for road condition and maintenance in new Department for Transport assessments. Under the DfT's traffic light grading system, Somerset scores green for the condition of its A roads, B and C roads, and unclassified roads. The Council also scores green for its maintenance approach. Overall, the Council is rated amber however, due to a red rating on capital spend. You can report

****Budget Consultation Highlights Mixed Views and Low Confidence:** Somerset Council's December 2025 budget consultation attracted more than 1,400 responses and showed divided public opinion on council tax and spending priorities. The results of this survey (which attracted more than 1,400 responses) reveal that a slim majority of residents are happy to pay more to prevent further cuts to public services. However, a declining amount, 38% compared with 49% last year, want the council to have more control over how it spends its budget, in light of "perceived wasteful spending" on consultants and regeneration projects. Only 42% of respondents said they supported increasing council tax to bring Somerset Council in line with its unitary counterparts in the southwest (such as Cornwall, Dorset and Wiltshire) - down from 53% last year.

****Somerset Budget Setting Meeting Delayed:** A delay in an expected Government decision on whether Somerset Council can impose an 11% council tax rise this year has forced the authority to revise its budget setting timetable. A decision is not expected until February 9th which means the Full Council meeting has moved from February 25th to March 4th to agree the 2026-27 budget.

****Disabled Resident Challenges takes council to court over tax support:** A disabled Taunton resident has been granted permission to bring a judicial review against Somerset Council over changes to its council tax reduction scheme, which he argues are discriminatory and unlawful. Before the changes he paid no council tax under the previous scheme, but following his migration from legacy benefits to Universal Credit he now pays around 90% of his bill, leaving him with an annual charge of more than £1,100 despite no change in his circumstances. A hearing is expected later this year, and the outcome could have wider implications for Somerset's council tax reduction scheme.

****Bus Service Improvements:** Somerset Council is considering a package of proposals to improve bus services across the county following confirmation of new government funding under the Bus Service Fund. The funding includes around £11.4 million in capital investment over four years to 2029/30 and £13.1 million in revenue funding over three years to 2028/29. Discussions are focusing on priorities for 2026/27, with potential themes including continued support for existing bus schemes, better integration with rail services, expansion of demand responsive transport, improved access to key destinations, and work on transport hubs, ticketing and real time information. Measures and costings are still being developed, with final decisions expected to be taken by Somerset Council's Executive Committee in early March.

****Expanded Recycling Service for Communal Properties:** From March 2026, Somerset households with communal recycling collections will receive an expanded service bringing them in line with national Simpler Recycling regulations. Residents in flats and other communal properties will be able to recycle a wider range of materials, including food waste, cartons, plastic bags and wrappers, alongside existing collections for plastics, metals and glass. The changes include a new weekly food waste collection, new fortnightly collections for cartons and plastic bags and wrappers, and the introduction of new communal recycling bins with coloured lids to separate materials. Households will also receive a kitchen food waste caddy and liners, with the new service launching in the week beginning 30 March 2026.

****Health Visitors to Offer Childhood Vaccinations at Home:** Somerset is taking part in a national NHS pilot allowing health visitors to deliver routine childhood vaccinations in family homes, helping children who face barriers to attending GP appointments. The yearlong pilot focuses on families affected by issues such as travel, childcare, language barriers or GP registration, with a national rollout planned from 2027. Somerset Council is contributing through a health visitor led immunisation programme already in place locally, with around 400 children expected to benefit. From this month, children will also be offered protection against chickenpox as part of the routine NHS vaccination schedule through the combined MMRV vaccine.

****Consultation on Proposed Reforms to the National Planning Policy Framework:** The Government has launched a consultation on proposed reforms to the National Planning Policy Framework, seeking views on a revised approach to national planning policy in England. A draft version of the Framework has been published alongside the consultation and sets out the proposed policy wording, subject to feedback. The consultation runs from 16 December 2025 until 10 March 2026, and parish and town councils are encouraged to review the proposals and submit responses through the Government's Citizen Space portal here: <https://consult.communities.gov.uk/planning/proposed-reforms-to-the-national-planning-policy-f/>

****Residents Invited to Shape the Future of Adult Social Care:** Somerset Council is inviting residents, unpaid carers and organisations to share their views as it prepares a new Adult Social Care strategy for 2026 to 2029. The refreshed strategy will set priorities for the next three years and aims to reflect the experiences and needs of people who use care and support services, those who care for others, and professionals working in the sector.
