
**Frome Town Council 2025-26 AGAR**

We were one week late in publishing the External Auditors final report on the 2024-25 AGAR. After a number of question and answer emails with the PKFL office leading up to the 30 September deadline, the latest received on Saturday 28 September, we finally received the External Auditor's report on Monday 30 September. Having awaited the report for some time we read the outcome but missed the notification that the report had to be published the very next day.

On realising our error, one week later on 6 October 2025 we published the report on our website and Town Hall noticeboard providing the second exercise of public rights.




